## **Tamaya Amenity Facilities**

The Beach CDD has approved opening the Amenity Facilities on Wednesday May 20th

Below are the Guidelines that will be in place for the initial opening, we are going to monitor and operate at 50% of the facility capacity as listed in the pool and building permitted uses.

Fitness: Permitted Load: 48-50% - 24 Residents allowed

Pools: Permitted Load: Total for 3 areas 159 – 50% - 80 Residents allowed

The Tennis and Basketball Courts are open. Because of distancing guidelines no Basketball games can be played. The Playground is open.

Both Swimming Pools and the Fitness Facility will be opening on Wednesday May 20th, the hours of operation will be 8AM – 8PM. The pool slide will not be open for the initial startup, we will determine opening in the near future. Lifeguard training has been delayed due to the shutdown, we are scheduling the training as soon as we can and will notify resident with an update.

## **COVID-19 WARNING**

- The danger of exposure to the coronavirus that causes COVID-19 exists.
- By entering the pool, you take responsibility for your own protection and for disinfecting your hands and anything you touch in the pool area.
- Do not use the pool if you have a cough, fever or other symptoms of illness.
- Wash or disinfect hands before and after swimming. Please use proper hygiene and cleaning techniques at all times.
- Maintain at least 6 feet between you and other people who are not a part of your household.
- Group games, such as water polo, volleyball, etc., are prohibited.

## **Amenity Rules:**

- Persons in high risk groups are encouraged to take the necessary precautions prior to entering the Amenity Facilities including consulting their physician prior to using any of the CDD amenities.
- All residents using the amenities are required to abide by social distancing requirements and are strongly encouraged to bring sanitizer and other personal protection equipment as necessary.
- Residents using amenities should familiarize themselves with CDC recommendations for protecting themselves.
- RESIDENTS ONLY: No guests will be allowed for the initial opening time period.
- All residents will be asked to sign in with staff, the only gate for entering the facility will be through the breezeway.
- Pool furniture will be spread out to abide by social distancing, please do not move pool furniture from the location it has been set.
- Fitness cardio equipment will be operational with social distancing in place, please do not use the equipment that has been closed. Please wipe equipment before and after use.

- Fitness strength equipment and free weights are to be used with social distancing in place. Please wipe down equipment before and after use.
- Lifestyle Programing will be limited for the initial opening with consideration of social distancing guidelines.
- All other CDD Amenity Policies will be enforced.

All of the guidelines above are subject to restrictions from the Florida Department of Health, Duval County and other governmental authorities. We further recognize that changes in the number of local cases of the coronavirus level may result in changes to this plan without notice.

Thank you for your patience in this reopening, please be considerate of the other residents and follow the rules above so we can continue to keep the amenity facilities open.
